**SEPARABILITY:** If any provisions of this agreement shall be declared to be invalid or unenforceable in whole or in part such invalidity and unenforceability shall not affect the remaining provisions hereof which shall remain in full force and effect.

**GOVERNING LAW:** This Agreement is governed by the Laws of Anguilla, British West Indies and the Courts of Anguilla shall determine any action in regards to any matters arising out of this Agreement.
